# Lenoir-Rhyne University School of Occupational Therapy For Classes Starting August 25, 2025

OT is the therapeutic use of occupations to enhance successful participation and achievement in meaningful daily roles. The scope of OT services includes habilitation, rehabilitation, and enhancement of ability-related needs in physical, mental health and wellness. By using clinical reasoning and professional judgment to assess, analyze, and identify occupational challenges, targeted, occupation-based interventions are implemented. Through skilled interventions and engagement in meaningful daily activities, OT supports occupational performance in clients who have, or are at risk of developing, illnesses, injuries, diseases, disorders, conditions, impairments, disabilities, activity limitations, or participation restrictions.

#### LR'S OT CURRICULUM

LR's Master of Science degree in Occupational Therapy includes a 24-month curriculum sequence of 2 academic years including 2 summer sessions totaling 63 graduate credit hours. LR's OT program has two locations, 625 7<sup>th</sup> Ave NE Hickory, NC and 4201 N. Main St Columbia, SC. <u>www.lr.edu/ot</u>

Lenoir-Rhyne will increase enrollment in the Occupational Therapy program at the Hickory campus and pause admission to the OT program at our Columbia location beginning in fall 2025. This will not affect the enrollment or education of the two cohorts of OT students who are currently enrolled in Columbia. They will continue their program and graduate from the Columbia location.

LR's School of OT sponsors one OT program with cohorts in Hickory, NC and Columbia, SC. Program vision, mission, curriculum, and student learning outcomes are identical for both sites, incorporating the strategic use of asynchronous recordings to promote achievement of student learning outcomes. OT Graduates are eligible to take the National Board for Certification in Occupational Therapy (NBCOT) examination. To practice, OT students must pass the NBCOT exam and obtain state licensure. # OCCUPATIONAL THERAPY CLINICAL FIELDWORK

All OT students must successfully complete three Level I and two Level II fieldwork (FW) rotations to graduate to be eligible to take the NBCOT exam. During FW rotations, students are responsible for reliable transportation and arranging their housing before their FWII experiences start. Students must budget for related transportation and living expenses for FW experiences as Level II site locations typically require students to relocate as they may be <u>anywhere in the United States</u>.

#### ADMISSION

Verification of your application by OTCAS may take up to 10 business days to complete. Applicants will be notified when verified. Applications submitted during this current cycle will be considered for the upcoming fall admission. Indicate your campus of preference on your OTCAS application.

## EARLY DECISION FOR FALL 2025 ADMISSION

The Early Decision deadline is **October 15, 2024**. Applicants must meet the minimum admission criteria and have made LR's OT program their school of choice and will commit to enrolling if accepted. For consideration for early decision, applications must be verified by October 15, 2024, 11:59 PM (EST). Admission decisions are received within 2-4 weeks.

## **REGULAR DECISION FOR FALL 2026 ADMISSION**

The Regular Decision deadline is **January 15th, 2025**. For consideration for admission, your application must be verified by January 15, 2025, 11:59 PM (EST). Admission decisions are received within 4-6 weeks.

## FINAL DECISION FOR FALL 2025 ADMISSION

If seats are available, applications will be accepted for the Final Decision deadline, **April 15, 2025**. For consideration for admission, your application must be verified by April 15, 2025, 11:59 PM (EST). Admission decisions are received within 4-6 weeks.

## MINIMAL CRITERIA FOR OT APPLICATION REVIEW

1. Lenoir-Rhyne University will accept applications for the OT cohort Fall start through the Centralized Application Service for Occupational Therapy programs (OTCAS). OTCAS's application window opens in July. Our OT program has three dates for application review. Refer above for Decision Deadlines.

- 2. Completion of a baccalaureate degree from a regionally accredited college or university in the US, prior to matriculation.
- 3. Cumulative GPA (Grade Point Average) of 3.0 or higher.
- 4. Completion of all the prerequisite coursework with a cumulative GPA of 3.0 or higher on a 4.0 scale prior to being eligible for enrollment.
- 5. Completion of the following 8 prerequisite courses with a grade of B- or better: 1) Human Anatomy and Physiology I with lab, 2) Human Anatomy and Physiology II with lab, 3) Intro Psychology, 4) Abnormal Psychology, 5) Developmental Psychology, 6) Statistics (includes Intro to Statistics), 7) Sociology (includes Intro to Sociology) OR Anthropology (includes Intro to Anthropology), and 8) Medical Terminology.

Note: Prerequisite course completion must be within 5 years of application date unless waived following approval of prerequisite course waiver form. OT Waiver of Five-Year Limit Form. <u>https://www.lr.edu/occupational-therapy-ms/ot-waiver-five-year-limit</u> If you are unsure if a course you have taken satisfies the prerequisite requirement, you may submit the Prerequisite Inquiry Form. <u>https://www.lr.edu/occupational-therapy-prerequisite-inquiry</u>. Only submit this form if you are unsure.

- 6. Submit **3** letters of reference (evaluations). One letter of reference **must** come from a practicing **OTR**. Letters of reference must come from an OT/L (not a COTA), employer, supervisor, or professor and include their title/position/profession and total number of student observation hours.
- Essay (Reflective Statement): Submit a reflective statement (between 750 1000 words) in addition to the required general OTCAS personal statement, to convey your understanding of the OT profession. Applicants must respond to ALL five of the following questions:
  - a. Why OT? What did you learn about OT through your experiences? How do you define OT? What personal attributes make you a good fit for OT? Include experiences that demonstrate your leadership skills.
  - b. What is evidenced-based practice? How did you see it applied in service delivery? Why is it important for OT practice?
  - c. How do you maintain your positive well-being in times of stress?
  - d. What kinds of experiences have you had with people of cultural and diverse backgrounds different than your own that will prepare you for working with clients?
  - e. How would you encourage clients and honor their uniqueness when providing OT services?
- 8. Recommend minimum 40 hours of observational hours.
- 9. National Background Check:
  - a. Candidates for admission must be prepared to have a background check before enrolling in FW experiences.
  - b. Applicants convicted of a felony or misdemeanor may be denied certification or licensure as an occupational therapist. For eligibility information, contact NBCOT. Fieldwork sites may not permit participation in the clinical experience, thus serious consideration by the candidate must occur before application.
- 10. Priority consideration given to LR undergraduates, graduates of LR educational partners, and applicants who have relevant work experience or have earned a previous graduate degree.
- 11. Although an interview is not required, all applicants must be available to interview upon request.
